## **Digital SAT Suite of Assessments**

We recently announced that the SAT Suite of Assessments is going digital.

- Starting in March 2023, all students taking the SAT at international test centers will take the digital test.
- Starting in fall 2023, all students taking PSAT-related assessments will take the digital tests. SAT School Day and SAT Weekend administrations in the U.S. will still be paper and pencil.
- Starting in spring 2024, all students will take the full SAT Suite of Assessments digitally.

Closing Soon: Cobell Scholarship

Both merit- and need-based, the Cobell Scholarship is available to members of a U.S. federally recognized tribe who are enrolled in full-time study and are degree-seeking. Applicants must plan to attend or be attending any nationally, regionally, or industry accredited nonprofit, public, or private institution. The academic year 2022-23 undergraduate and graduate scholarship applications deadline is March 31, 2022. The summer scholarships application is available February 15, 2022, through May 3, 2022.

## **SAT Suite**

Where can I find more information about completing my testing invoice?

#### How do I access the PSAT-related assessments test ordering site?

Access to the <u>test ordering site</u> is managed by an access code created by College Board. You must use the code created for your school the first time you log in. Access codes were emailed to your school's test coordinator(s) and to your school's principal. Contact us if you don't have your school's access code.

#### How do I pay for my tests?

You'll use the <u>test ordering site</u> to provide important information that will be used to calculate your invoice. If you don't complete this process after test day, you'll still receive an invoice based on what you ordered and what you sent back. View your ordering dashboard on the test ordering site to see the dates relevant to your invoice for your ordered test. You'll also receive an email when invoicing is available for your ordered test. It's important that you log back in to the test ordering site during this time to validate your answer sheet counts and enter information to ensure your invoice is generated accurately.

#### How do I access score reports?

Score reports are available in the <u>K-12 score reporting portal</u>. If you've already used the portal, just sign in to access scores. If you haven't used it yet, you'll need two things:

- 1. A College Board professional account. If you don't have one, create an account now.
- 2. Permission from your institution's access manager. Every school, district, and state have an access manager.

After you create a College Board account, sign in to the score reporting portal. If you haven't been granted access yet, follow the links to learn who to contact.

#### When can students test?

The 2022 AP Exams will be administered in schools as paper and pencil exams over two weeks in May: May 2–6 and May 9–13. Occasionally, circumstances make it necessary for students to test late. To preserve the security of AP Exams, alternate forms are used for late testing. All students who participate in late testing at a given school must take these alternate exams on the scheduled late-testing dates at the scheduled times. Late testing occurs May 17–20, 2022. If you have conflicts that can't be resolved using these dates, please contact AP Services for Educators for assistance at 877-274-6474.

When will we get more information about audio recording for this year's

#### exams?

You can find details about available audio recording options in the <u>AP</u> <u>Coordinator's Manual, Part 2</u> (.pdf/7.9 MB) on pages 129–132. Updated directions for the Digital Audio Submission portal will be posted in April, and coordinators will receive an email with details.

The 2022 versions of the Digital Audio Capture (DAC) app will be available for download by mid-March 2022 for iPad and Chromebook. AP coordinators will receive an email notifying them when the app is available. Schools that choose to use the DAC app to record student responses must use the 2022 version of the app since files recorded using previous versions won't be accepted by the submission portal. If your school downloaded the previous year's version, you'll need to follow the prompts to accept updates when you open the app this year.

#### How do we move students in between different class sections?

Pages 76–77 of the <u>AP Coordinator's Manual, Part 1</u> (.pdf/19.8 MB) cover how to move a student from one class section in AP Registration and Ordering to another for the same subject. There are two options for moving the student. The AP coordinator can find them in AP Registration and Ordering, then select **Change Section** from the Actions column next to the student's name and class section. The other option is to have the student enroll in the new class section through My AP using the join code for the new section. By doing this, the student will be moved from the old section to the new section.
