# SAT Fee Waiver Codes

## Accessing Codes and Frequently Asked Questions

Delivering fee waivers through the [K-12 score reporting portal](#) is a streamlined process that allows access to benefits for all eligible students.

- On August 14, 2025, all existing fee waiver codes expired. Schools now have a new set of fee waiver codes (beginning with FW25) in the K-12 score reporting portal. Please be sure to distribute these new codes to all eligible students who have not yet redeemed one of the past codes in their account to activate their fee waiver benefits.
- Schools received SAT® fee waivers through College Board's K-12 score reporting portal in August and can use them for upcoming SAT administrations. In the K-12 score reporting portal, go to the **Downloadable Reports** tab and then select **Other Report Downloads**. You must have detail- or summary-level access to view these reports.
- If you need assistance accessing the K-12 score reporting portal, please ask your school's access manager to grant you detail or summary access or consult the K-12 score reporting portal [Help page](#).

1. Select **Downloadable Reports**, either the tab at the top or on the home screen.
2. Your file of fee waiver codes will appear under **Other Report Downloads**. If you don't see the fee waiver file, select the **See More** option.
3. The fee waiver code file will be a spreadsheet that uses the following naming convention:  
**[Start of School Year]\_SAT\_Fee\_Waiver\_Codes\_[Your AI Code].csv**  
For example, a school receiving fee waiver codes for the 2025-26 year with AI code 123456 would have a file named **2025\_SAT\_Fee\_Waiver\_Codes\_123456.csv**. New codes start with FW25.

## FAQs

### Has the K-12 Score Reporting Portal Changed?

Yes! The [K-12 Score Reporting Portal home page](#) has been updated, making it easier to find the reports you need. There are five organized sections:

- **Search by Student** – with refreshed search results.
- **SAT & PSAT-Related Scores and Registrations** –view results by administration, season, or academic year; schedule reports directly. This is where you'll find the student roster report.
- **Downloadable Reports** – ESR files and other downloads, [including fee waiver codes](#), in one place.
- **More Online Reports & Tools** – includes BigFuture School app reports, Connections, Cohort Growth, Skills Insight, Educator Question Bank, and National Recognition Program reports.
- **Help Resources** – updated guides, refreshed documentation, and carousel access to reporting support.

### How do I distribute fee waiver codes?

Schools use a variety of methods to distribute fee waiver codes to students. You should do what works best for your school. Some schools email the codes to students, offering an easy-to-find record of each fee waiver code and the date sent to each student. Emailing codes also allows students to copy and paste the code when registering online for the SAT. You may want to maintain and track the fee waiver codes that are distributed through the school year using our [Educator SAT Fee Waiver Codes Tracking Form](#). Use the Student Roster Report to confirm students who have tested using a fee waiver code. For additional strategies, refer to [Strategies for Using SAT Fee Waiver Codes](#).

### Can I save the fee waiver code file to my laptop/computer?

Yes. We recommend saving to a shared file so you and your colleagues can track code distribution together and avoid distributing the same code to different students.

### What will happen to the fee waiver codes I was tracking before August 14?

Codes sent before August 14, 2025 have expired and are no longer usable. If you are tracking any students who have one of these codes but have not used it yet, they will need a new code that begins with FW25.

### If a student already has access to their SAT Fee Waiver Benefits, do they need a code?

No, if a student already has access to their SAT Fee Waiver Benefits, the student does not need a new fee waiver code. The student should be able to see their benefits in their College Board account and will not be prompted to enter a fee waiver code when requesting score reports or registering to take the SAT.
